The conflict of interest policy is reviewed annually at a meeting of the Board of Directors. All Board members are required to certify annually by their signature that they have reviewed the policy, that they understand it, and they will comply with it.

The Executive Committee reviews salaries comparable to other like-sized agencies in accordance with budget size and years of service. The Executive Director is asked to leave the board meeting when the Executive Committee discusses the Executive Director's compensation with the Board of Directors. The salary deliberation and discussions are noted and documented by the secretary in the Board of Directors minutes which are submitted for approval at the next session.
